

Kimberly Heights School Modified Hybrid Plan

Dear Parents,

Based on the current metrics in our area, vaccinations of staff, and current CDC guidelines, KHS will implement a modified hybrid model. This model will allow us to continue giving direct instruction to our students while keeping everyone at a safe social distance.

On Tuesday March 9th, a new survey will be sent to all district families. The survey will give parents an opportunity to select one of the following three options for the remainder of the school year.

- **Option 1:** Students will attend school in person <u>4</u> days a week. (2 days will consist of live instruction in their classroom with their classroom teacher & 2 days students will participate in class virtually using their device with a supervising adult. Students will not be in their classroom with their assigned teacher).
- **Option 2:** Students will attend school in person <u>2</u> days a week and will be remote from home 2 days a week.
- **Option 3**: Students will remain remote for the remainder of the school year.

Our modified hybrid model consists of the following:

- Direct instruction will be live streamed for all remote learners.
- Students who select 2 days in-person learning will continue the current hybrid schedule that is currently in place.
- Students who select 4 days of in-person learning will follow a hybrid model based on their last name.
 - <u>A-L students:</u>
 - Monday and Tuesday students will have live direct instruction with their classroom teacher.
 - Thursday and Friday students will participate in class virtually using their device with a supervising adult. Students will not be in their classroom with their assigned teacher.
 - Wednesdays are asynchronous (independent student assignments posted).

• <u>M-Z students:</u>

- Monday and Tuesday students will participate in class virtually using their device with a supervising adult. Students will not be in their classroom with their assigned teacher.
- Thursday and Friday students will have live direct instruction in their classroom with their assigned teacher.
- Wednesdays are asynchronous (independent student assignments posted).

Although our hopes were to have all students in person receiving live direct instruction, the square footage in our classrooms limits the number of students that can be in accommodated as we follow safety protocols.

We are excited to enter this new phase before the end of the school year.

Hybrid Instructional Plan

Expectations Enforced for ALL Students/Staff:

- Masks are to remain on at all times (covering the nose and mouth).
- 6ft distancing is maintained between students during instruction and while in the building.

Student Expectations:

• Students will be responsible for transporting their school issued iPad, charger, and headphones, to and from school on a daily basis.

Instructional/Classroom Expectations:

- Direct instruction will be live streamed for all remote learners.
- Students on-site will follow a hybrid model based on their last name schedule.
 - <u>A-L Students:</u>
 - Monday and Tuesday students will have live direct instruction in their classroom with their assigned teacher.
 - Thursday and Friday students will participate in class virtually using their device with a supervising adult. Students will not be in their classroom with their assigned teacher.
 - Wednesdays are asynchronous.

• <u>M-Z Students:</u>

- Monday and Tuesday students will participate in class virtually using their device with a supervising adult. Students will not be in their classroom with their assigned teacher.
- Thursday and Friday students will have live direct instruction in their classroom teacher.
- Wednesdays are asynchronous.

<u>Arrival:</u>

• Car riders will arrive at door 1. Students will be screened and have their temperature checked by our school nurse.

MTSS:

• All MTSS groups will remain virtual.

Lunch:

- School lunches will be delivered to classrooms.
- Home lunches should be sent to school in a brown paper bag.

Attendance:

- Students who are remote from home will complete the attendance form on a daily basis.
- Students who are physically in the building do NOT have to complete the online attendance form.

Dismissal:

- Car riders are dismissed first through door 1.
- All students will have a colored tag placed on their bookbag to identify their transportation status. Please do not remove.
