



# Internet HotSpot Request Form

Arbor Park School District 145 is instituting an Internet Hotspot checkout program for remote learners. Students who are in need of an Internet connection can check out a Hotspot during remote learning. District 145 has partnered with T-Mobile's EmpowerED Program to provide Internet access to students. HotSpots are on a first come, first serve basis and are not guaranteed.

## HotSpot Request Requirements:

- Absolutely no Internet Access at Home (AT&T, Comcast, etc.)
- No smart phone that can provide hotspot access to the tablet
- Families are included in our free or reduced program

The Hotspots contain internet filtering and monitoring software. Student devices connected to the Hotspot have additional filtering installed directly on the student device. Parents are advised that content filtering and monitoring tools while using the Internet Hotspot is not completely fail-safe. I, as parent/guardian of the student listed below: (1) understand that access is designed for educational purposes and that, although the District has taken precautions to eliminate non-student material, it is impossible for the District to restrict access to all inappropriate materials; (2) agree to hold harmless the District, its Board of Education, Board members, employees, and agents, for any losses, claims, damages, causes of action, or injuries of any kind that result from materials or software accessed by my child via District Technology; (3) understand that my child must follow all Acceptable Use and Board Policies, Bring Your Own Technology (BYOT) Program, and their administrative procedures; (4) understand that the District and/or its agents may access and monitor at any time, without prior notice or consent, my child's use of District Technology, including but not limited to District equipment and devices, the Internet, email services, and any materials stored on, transmitted through, or received by my child using the District's networks or devices; (5) understand that if my child violates Board policy, administrative procedures, or this Authorization, my child's access privileges may be restricted or revoked and disciplinary action may be taken; (6) accept full responsibility for supervision if and when my child's use of District Technology is not in a school setting; (7) have discussed the terms of this Authorization with my child; and (8) understand this signed Technology and Acceptable Use Policy will be in effect as long as my child is in attendance in a District 145 school, unless written notification to the contrary is received by the school principal. Hotspots are district property and asset tagged belonging to Arbor Park School District 145 and must be returned upon our request. Parents are responsible for the device. If lost, stolen, or not turned in, the replacement cost is \$100 and will be charged to your PushCoin account.
